Dr. Philip Benjamin Matching **Grant Program**

What is the Dr. Philip Benjamin Matching Grant Program?

The Dr. Philip Benjamin Matching Grant Program provides the opportunity for the Florida College System (FCS) to have contributions¹ from private donors matched by state appropriations.² Each FCS institution and the statewide FCS Foundation³ are eligible to participate in the program.⁴

How is the program administered?

The program is administered in accordance with rules established by the State Board of Education.⁵ The state board is responsible for specifying the process for the submission and approval of requests for matching funds.⁶

Each FCS institution must establish a matching grant program fund as a depository for private contributions and matching state funds received under the program. The foundation for each FCS⁷ institution is responsible for the maintenance, investment, and administration of the institution's matching grant funds.⁸ Each FCS institution must submit an annual expenditure report to the state board that tracks the use of matching funds, as well as an annual financial audit to the Auditor General and state board for all receipts and expenditures.⁹

The statewide FCS Foundation must also annually submit a financial audit for all receipts and expenditures to the Auditor General and the state board for review. 10

How are state matching grants determined?

Contributions received by February 1st are eligible for state matching funds if the gift has been approved by the board of trustees (BOT) for a FCS institution or the Board of Directors for the FCS Foundation as being in alignment with the applicable entity's mission and goals. 11 The state

board submits a request for state matching funds for eligible contributions as part of its Legislative Budget Request. 12

The matching ratio for contributions specifically designated to support scholarships, student loans, or need-based grants is \$1 of state funds to \$1 of contributions. The matching ratio for contributions for other eligible purposes is \$4 of state funds to \$6 of contributions with a minimum required contribution of \$4,500. The matching ratio for contributions with a minimum required contribution of \$4,500.

FCS institutions are required to notify private donors when there is a substantial delay in the availability of state matching funds for this program.¹⁵

What are the allowable uses for the funds?

The BOT of a FCS institution and the state board are responsible for determining the uses of the program funds by each institution. Allowable uses include, but are not limited to expenditures for: scientific and technical equipment; scholarships, loans, or need-based grants; and other activities that will benefit current and future students, improve the quality of education at the institution, or enhance economic development in the community.¹⁶

How much funding has been provided for the program?

State matching funds were not appropriated for the program for the 2008-09, 2009-10, and 2010-11 FYs. The last state appropriation was for the 2007-08 FY in the amount of \$48,658,783. The Legislature has appropriated a total of \$324,220,860 in matching funds for the program since its creation in 1983. 19
