#### Funding the Fight Against Cancer

In the fight against cancer, research is one of our strongest weapons. The Moffitt Cancer Center, located right here in Tampa Bay, has had a tremendous, worldwide impact on the search for a cure.

This year I filed legislation that would have allowed Moffitt an increase in revenues generated from the state cigarette tax to expand facilities, create jobs, and increase research capacity. While our initial effort fell short, I am proud to report to you that we extended by twenty years, Moffitt's eligibility to receive state funding, allowing additional capacity to bond expansion projects that will lift our areas economy.

I remain committed to supporting Moffitt Cancer Center's mission and look forward to the day we witness the



ground-breaking for the next generation of cancer care.

#### **Promoting Innovation**

From before the time I was first elected, I have been committed to the idea that Florida can be the #1 ecosystem for tech talent and investment in the country. Our willing laws have not been updated since English common law first developed rules for the execution of wills in the 1600s.

For this reason, I sponsored HB 277: Wills and Trusts, to update our willing statutes and bring Florida into the 21st century. This bill would have enabled individuals to create wills electronically, and be signed electronically by you, two witnesses, and a notary public. HB 277 was vetoed by the Governor, despite passing both the House & Senate with large majorities. I will continue to be relinquishing in my advocacy for innovation, and I look forward to working on this and other tech projects in the sessions to come.

#### Legislature Passes Uniform Rules for Ridesharing Companies

Two of the most significant bills to become law this year were the abolition of Hillsborough County's Public Transportation Commission, and the approval of a statewide set of standards governing and authorizing ridesharing services such as Uber & Lyft. I am proud to have sponsored both of these bills in the Florida House, which clear the way for innovation and improved transportation options for Florida's residents.

#### Tax Cuts for Millions of Floridians

Putting money back in the hands of taxpayers continues to be the best policy for promoting economic development. This year, the Legislature passed measures to return \$1.3 billion to Floridians. This means more money in the pockets of students, families, business owners, homeowners, and many other Floridians.

Additionally, I am proud to have voted for an increase in the homestead tax exemption, extending existing exemptions by up to \$25,000 on the assessed value of your home between \$100,000 and up to \$125,000. This property tax cut will be on the 2018 ballot for voters to decide on approval of this tax relief measure.

#### Legislature Passes Balanced Budget

The legislature passed a constitutionally-required balanced budget for 2017-2018. The budget cuts wasteful spending while funding our state's critical needs, including significant investments and reforms in education. This year's budget also includes tax cuts that put more money in the pockets of students, families, business owners, homeowners, and many other Floridians. Finally, the budget responsibly plans for the future by placing \$3.2 billion in reserves to prepare for any unforeseen future economic uncertainty. This budget not only saves taxpayers money by eliminating wasteful spending and cutting taxes, but ensures our state's critical needs are met. I was proud to support this great budget that puts Floridians first.
