18 (8) Notwithstanding any provision of law to the contrary,
19 a live quarter horse racing permitholder shall be required to
20 maintain the continuing validity of a quarter horse racing
21 permit provided that the permitholder conducts at least 40 days
22 of pari-mutuel wagering activities under each annual operating
23 license issued to the permitholder after the effective date of
24 this subsection. The election of a quarter horse racing
25 permitholder not to conduct a full schedule of live racing shall
26 not disqualify the permitholder from licensure to conduct any
27 other type of pari-mutuel wagering activity or to conduct any of
28 the activities authorized under chapters 551 and 849. A quarter
29 horse racing permitholder shall make its election not to conduct
30 a full schedule of live racing in its annual application for an
31 operating license under s. 550.01215. For state fiscal year
32 2015-2016 only, all quarter horse racing permitholders shall
33 have a period of 30 days after the effective date of this
34 subsection to apply for an annual operating license under the
35 provisions this subsection. Upon the timely election of a
36 quarter horse racing permitholder not to conduct a full schedule
37 of live racing, the provisions of ss. 550.002(11), 550.615,
38 551.104(4)(c), 551.104(10), 849.086(5)(b), and 849.086(13)(d)
39 shall not be applicable to or restrict the issuance of any
40 license applied for by such permitholder to conduct any of the
41 activities authorized under chapters 550, 551, and 849. ~~To be~~
