Journal of the House of Representatives for a Special Session of the 80th House since Statehood in 1845, convened by Proclamation of the Governor and held at the Capitol in the City of Tallahassee in the State of Florida on Monday, October 22, 2001.

Pursuant to the proclamation, the House was called to order by the Honorable Tom Feeney, Speaker, at 9:00 a.m.

The following proclamation was read by John B. Phelps, Clerk of the House:

PROCLAMATION

State of Florida

Executive Office of the Governor

Tallahassee

TO THE HONORABLE MEMBERS OF THE FLORIDA SENATE
AND HOUSE OF REPRESENTATIVES

WHEREAS, on September 11, 2001 our country was struck by horrific acts of terror that took the innocent lives of thousands and injured many others, and that disrupted air transportation and the normal conduct of this nation's commercial and financial markets; and

WHEREAS, the economy and therefore the anticipated revenues of the State of Florida, as in the rest of the country, have been adversely affected by these acts of terror, and to the extent our economy relies on air transportation and tourism, Florida is uniquely impacted; and

WHEREAS, the Governor considers it necessary to reduce appropriations to offset the expected decline in revenues; and

WHEREAS, it is in the best interest of the citizens of the State of Florida to call a Special Session so that the Legislature may give full and adequate consideration to the reduction of this fiscal year's appropriations in anticipation of decreased revenue.

NOW, THEREFORE, I, Jeb Bush, Governor of the State of Florida, by virtue of the power and authority vested in me by Article III, Section 3(c)(1), Florida Constitution, do hereby proclaim as follows:

Section 1.

That the Legislature of the State of Florida is convened in Special Session commencing at 9:00 a.m., Monday, October 22, 2001, and extending through 11:59 p.m., on Thursday, November 1, 2001.

Section 2.

That the Legislature of the State of Florida is convened for the sole and exclusive purpose of considering the reductions to this fiscal year's appropriations from the general revenues of the state that are needed

to deal with the anticipated decline in revenue in the aftermath of these acts of terror.

Section 3.

That the committees of either house of the Legislature are authorized to consider legislation within the purview of this proclamation from this date forward.



IN TESTIMONY WHEREOF, I have hereunto set my hand and caused the Great Seal of the State of Florida to be affixed to this Proclamation convening the Legislature in Special Session at the Capitol, this 10th day of October, 2001.

Remarks by Speaker Feeney

Speaker Feeney: There's a portion of the Governor's Proclamation, Section 3, that indicates that, and I'm going to quote, "...the committees of either house of the Legislature are authorized to consider legislation within the purview of this proclamation from this date forward." The suggestion being that the Governor has authorized our committees to meet. I would suggest, just as we respectfully love our independent sister branch in the judiciary but don't need their permission to meet, that we love our Governor in the executive branch, but we would suggest, the Legislature doesn't need their approval either, for our committees to undertake business.

We pray for our soldiers. We pray for those detainees who are on the battlefield in Your service. We pray for families and their comfort during this struggle. We pray for the leadership of our nation, our state, and our world. Help them, and help us, to show love, help us to grow love.

Finally, we pray for the peace of Jerusalem. May they prosper who love You. We thank You for being a holy and just God, who punishes evil. Thank You for being a loving and compassionate God, who rewards good. We thank You for being our nation's God. Blessed is the nation whose God is the Lord and the people whom He has chosen for His own inheritance. We, Your people, love You and petition this prayer in Your Son's holy name, Yeshua, Jesus the Christ. Amen.

By the authority vested in me as Governor of Florida, under the provisions of Article III, Section 8, of the Constitution of Florida, I do hereby withhold my approval of and transmit to you with my objections, House Bill 863, enacted during the 103rd Session of the Legislature, since statehood in 1845, during the Regular Session of 2001, and entitled:

An act relating to North Springs Improvement District, Broward County;...

This local bill provides for the membership of the Board of Supervisors of the North Springs Improvement District to change from three to five members and changes the manner in which the supervisors are elected. General law, section 189.4051(2)(a), Florida Statutes, sets out the procedure for changing special district board membership from three to five members and for changing the manner in which the supervisors are elected, and this procedure includes the requirement for a public referendum and a petition signed by ten percent of the qualified electors of the district. House Bill 863 bypasses this established process and does not afford an opportunity for citizens to vote on the manner in which they will be governed. Bypassing these provisions compromises the right of the residents to express their wishes regarding the district's Board of Supervisor membership and manner of election.

For this reason, I am withholding my approval of House Bill 863, and do hereby veto the same.

By the authority vested in me as Governor of Florida, under the provisions of Article III, Section 8, of the Constitution of Florida, I do hereby withhold my approval of and transmit to you with my objections, House Bill 931, enacted during the 103rd Session of the Legislature, since statehood in 1845, during the Regular Session of 2001, and entitled:

An act relating to Coral Springs Improvement District, Broward County;...

This local bill provides for the membership of the Board of Supervisors of the Coral Springs Improvement District to change from three to five members and changes the manner in which the supervisors are elected. General law, section 189.4051(2)(a), Florida Statutes, sets out the procedure for changing special district board membership from three to five members and for changing the manner in which the supervisors are elected, and this procedure includes the requirement for a public referendum and a petition signed by ten percent of the qualified electors of the district. House Bill 931 bypasses this established process and does not afford an opportunity for citizens to vote on the manner in which they will be governed. Bypassing these provisions compromises the right of the residents to express their wishes regarding the district's Board of Supervisor membership and manner of election.

For this reason, I am withholding my approval of House Bill 931, and do hereby veto the same.

By the authority vested in me as Governor of Florida, under the provisions of Article III, Section 8, of the Constitution of Florida, I do hereby withhold my approval of and transmit to you with my objections, Council Substitute for Committee Substitute for House Bill 1053, enacted during the 103rd Session of the Legislature, since statehood in 1845, during the Regular Session of 2001, and entitled:

An act relating to Transportation Department; . .

Council Substitute for Committee Substitute for House Bill 1053 was originally created to address issues that the Department of Transportation felt would improve overall administration of various transportation programs in our state. As the bill moved through the

legislative process, a multitude of different proposals were added onto the original language. By the time Council Substitute for Committee Substitute for House Bill 1053 was approved on the last day of session it had become a mammoth piece of legislation, most commonly referred to as a "train." As presented to me for approval, Council Substitute for Committee Substitute for House Bill 1053 contains the legislative packages proposed by two separate state agencies—the Department of Transportation and the Department of Highway Safety and Motor Vehicles—plus many other proposals, most of which had been created as separate bills but as stand-alone issues failed to win the required approval of legislative committees or the full House and Senate. In its final form, Council Substitute for Committee Substitute for House Bill 1053 exceeds 300 pages and makes almost two hundred different changes to current Florida law.

As would be expected, a bill of this size and complexity brings forth concerns. For one, the sheer range of issues addressed in Council Substitute for Committee Substitute for House Bill 1053 provides a textbook example of logrolling, the kind that makes it difficult to provide Floridians with good, sound public policy. Often during the legislative process, issues are amended onto a bill that are not totally in keeping with the bill's original purpose, but are sufficiently related so as to not violate the Constitution's single subject rule. In my view, the diversity and sheer number of issues contained in Council Substitute for Committee Substitute for House Bill 1053 goes beyond what has been marginally accepted in the past, and leaves the legislation vulnerable to legal challenges by aggrieved stakeholders, forcing the state into costly and unnecessary litigation.

As to the content of Council Substitute for Committee Substitute for House Bill 1053 itself, the bill does contain several good proposals, such as the waiver of fees for Pearl Harbor Survivor and Purple Heart license plate holders, the creation of a Turnpike Enterprise to oversee Florida Turnpike operations, and allowing Department of Transportation employees to essentially become private contractors and bid on Department projects.

However, the bill also contains several provisions of questionable benefit to the people of Florida. Among the provisions that concern me are increases in fees for motorists, legislation that I vetoed last year relating to driving schools, the relaxing of penalties for unsafe drivers, the increased regulation of motorized scooters, the watering down of property rights despite other provisions in the bill that strengthened the rights of property owners, and allowing third party access to confidential auto insurance coverage information. Taken together these and other unmentioned issues constitute a block of questionable public policy sufficiently objectionable as to override Council Substitute for Committee Substitute for House Bill 1053's positive aspects. Unfortunately, such an occurrence is a likely by-product of creating unwieldy train legislation. Policymakers in the executive and legislative branches alike should not be forced as a matter of procedure to accept a multitude of issues creating bad public policy as a condition of enacting policies of benefit to our citizens. Our laws and Constitution were designed to prevent against this type of practice.

In closing, I would encourage the sponsors of this bill to repackage the good ideas contained in Council Substitute for Committee Substitute for House Bill 1053 and create new legislation for next year.

For the reasons provided above, I am withholding my approval of Council Substitute for Committee Substitute for House Bill 1053, and do hereby veto the same.

By the authority vested in me as Governor of Florida, under the provisions of Article III, Section 19(b), of the Constitution of Florida, I do hereby withhold my approval of and transmit to you with my objections, Sections 42 and 43, comprising specific appropriations and

related proviso, of House Bill 1225, enacted during the 103rd Session of the Legislature, since statehood in 1845, during the Regular Session of 2001, and entitled:

An act relating to the economic development; . . .

The specific appropriations and accompanying proviso which comprise Sections 42 and 43 of House Bill 1225 are hereby vetoed. House Bill 1225 contains a \$1 million appropriation to promote the growth of employment in the information technology industry, worded in such a way as to primarily benefit a single company. Also, \$500,000 is appropriated in the bill to retroactively refund sales taxes paid by aircraft pilot and flight crew training facilities. Neither of these appropriations went through a formal review process, nor do they in my view provide a statewide benefit to the citizens of Florida.

The appropriations in question provided in House Bill 1225 are as follows:

Section 42. The sum of \$1,000,000 is appropriated from nonrecurring General Revenue funds for Fiscal Year 2001-2002, to the Executive Office of the Governor, Office of Tourism, Trade and Economic Development to contract with Enterprise Florida, Inc., to promote the growth of employment in the Information Technology Industry and expended as follows: There shall be paid an incentive payment to a qualifying corporation in an amount equal to the product of \$3,000 and the total number of full-time Florida employees in the employ of the qualifying corporation as of December 31, 2001. Incentive payments shall be made to qualifying corporations submitting applications after February 15, 2002 until \$1,000,000 appropriated for this purpose is depleted, in the order in which applications from qualifying corporations are received by Enterprise Florida, Inc. The amount of the incentive payment made to an individual corporation cannot exceed the gross compensation of all new full-time Florida employees hired between January 1, 2001 and December 31, 2001. For these purposes "qualifying corporation" means an Information Technology Industry corporation (1) whose percentage increase in full-time Florida employees equals or exceeds ten percent or whose new full-time Florida employees is at least 50 and (2) the average gross compensation of all its full-time Florida employees for calendar year 2001 exceeds \$60,000. A corporation is an "Information Technology Industry" corporation if it derives more than 50% of its revenues during calendar year 2001 from (1) designing, developing, manufacturing, processing, or producing computer software, including but not limited to operating systems, software applications, internet enablement software, business information systems software, and enterprise resource planning software, or (2) the sale to end users of voice or data services delivered over a broadband facility capable of transmission in speeds in excess of 128kbps. "New full-time Florida employees" means the number of full-time Florida employees as of December 31, 2001 less the number of full-time Florida employees as of December 31, 2000. "Full-time Florida employee" means an employee who performs duties for an average of 36 hours or more per week and is reported on the corporation's Florida Unemployment Compensation Report, Form UCT-6. "New employee" means an employee hired or relocated to Florida on or after January 1, 2001 and during calendar year 2001. An individual employed in Florida by a member of the same affiliated group of corporations at any time during the 12 months preceding the date of hire or relocation by the qualifying corporation shall not be counted as a new employee. "Gross compensation" means all amounts reported in Box 5 of the employee's Federal Form W-2, Wages and Tax Statement. Average gross compensation shall mean total gross compensation for all full-time Florida employees for calendar year 2001 divided by the number of full-time Florida employees as of December 31, 2001. A qualifying corporation shall include with its application for incentive payments documentation reflecting compliance with the foregoing job growth and compensation requirements. Such documentation may include W-2 forms, state unemployment compensation tax returns or other supporting schedules. The funds subject to this proviso shall be subject to the provisions of s. 216.301(1)(a).

Section 43. There is appropriated from nonrecurring general revenue a refund of sales taxes paid in fiscal year 2001-2002 to any facility, school, or business that is certified under Part 142 of Federal Aviation Regulations and trains aircraft pilots and flight crews for approval,

certification, or regulation by the Federal Aviation Administration, or a comparable foreign national government regulatory agency. Total refunds to all such facilities, school, or businesses shall not exceed \$500,000.

The portions of House Bill 1225 which are set forth herein with my objections are hereby vetoed. All other portions of House Bill 1225 are hereby approved without signature.

By the authority vested in me as Governor of Florida, pursuant to Article III, Section 8, of the Constitution of Florida, I do hereby withhold my approval and transmit to you with my objections, House Bill 1519, enacted during the 103rd Session of the Legislature since Statehood in 1845, during the Regular Session of 2001, and entitled:

An act relating to disability services

Expanding services to people with disabilities has been one of our Administration's highest priorities. Since taking office, we have increased funding by 75 percent for programs that enable Florida's most vulnerable citizens to access the services they need to live a productive and dignified life. I agree with the need for an efficient information and referral system in this regard. I applaud and thank Representative Kim Berfield and Senator Richard Mitchell for their wisdom in perceiving the need for a comprehensive "one-stop" information and referral service for people with disabilities and their tireless efforts over the 2001 Legislative Session in passing House Bill 1519.

The proposed "Clearinghouse on Disability Information Office" in the Department of Management Services would develop and maintain a statewide toll-free 800 telephone referral system for information about a wide variety of services for persons with disabilities. A web site would be developed to consolidate information about disabilities from many sources. The intent of this legislation is to pull together in one place the information and telephone referral services offered by several state agencies.

The new office contemplated by this bill would provide information on most types of disabilities, including mental retardation, spinal bifida, cerebral palsy, down syndrome, paraplegia, autism, mental illness, hearing loss, blindness and developmental disabilities. The initial plan for the office would include state and federal resources and would add information about local and community-based services at a later date.

The concepts set forth in this bill are excellent ideas and address unmet needs for central information and referral services about disabilities. I agree with and support the need for an efficient program to provide such services. However, there is also already established at the Department of Management Services, an organizational structure that with additional resources and responsibilities can provide all of the services envisioned by House Bill 1519.

The department currently houses the "Americans With Disabilities Act Working Group," created by Executive Order 99-80. The 15-member Working Group represents a broad cross-section of persons with disabilities and provides technical training and assistance to all state agencies, local governments and any interested party about compliance with the Americans with Disabilities Act (ADA). In conversations with various representatives of the disabled community, the interests represented in House Bill 1519 and the leadership of the Working Group, it is clear that the Working Group can assume the functions provided in House Bill 1519 without the need to create an additional office and council.

As such, I am today revising Executive Order 99-80 to *fully* integrate the duties, responsibilities and functions of the information and referral services assigned by House Bill 1519 to the Clearinghouse on Disability Information Office. This revised working group and office will be known

as the Americans with Disabilities Informational Clearinghouse and Working Group ("Working Group"). I am also today directing the Department of Management Services to ensure that the structure and representation on the Clearinghouse meets the needs of the program as contemplated in House Bill 1519.

Rest assured that the integration of the excellent concepts in the bill with the ongoing, existing efforts of the Americans with Disabilities Act Working Group will create a better service for our most vulnerable citizens and help them quickly get the information and services they need in the most effective manner possible.

I again commend the legislative bill sponsors. Their leadership has resulted in these immeasurably positive changes for individuals with disabilities. With the revisions to Executive Order 99-80, I am withholding my approval of House Bill 1519 and do hereby veto the same.

By the authority vested in me as Governor of Florida, under the provisions of Article III, Section 8, of the Constitution of Florida, I do hereby withhold my approval of and transmit to you with my objections, House Bill 1717, enacted during the 103rd Session of the Legislature, since statehood in 1845, during the Regular Session of 2001 and entitled:

An act relating to the Division of Dairy Industry of the Department of Agriculture and Consumer Services; . . .

The provisions of another bill, House Bill 501 which abolishes 43 boards, councils and commissions, passed the Legislature subsequent to House Bill 1717 and provides for the reversal of provisions in House Bill 1717. As such, House Bill 1717 has no effect or impact, thereby negating the need to process this legislation.

For this reason, I am withholding my approval of House Bill 1717, and do hereby veto the same.

Resignation

Pursuant to Article III, Section 15 of the Florida Constitution, a special election was called by executive order. The first special primary was held on July 24, 2001; the second special primary on September 4, 2001; and the special general election was held on October 16, 2001.

Election of Rep. Greg Evers

The Department of State notified the Clerk of the House that Rep. Greg Evers had been elected on October 16, in a special general election as a Member from the 1st District, replacing Rep. Jeff Miller, who had resigned effective October 16.

Oath of Office Administered

On motion by Rep. Byrd, the Speaker appointed Reps. Melvin, Kilmer, Maygarden, Brown, Bense, and Benson as a committee to escort Rep. Evers and his family to the well for the administration of the Oath of Office.

Rep. Brown was recognized for introduction of Rep. Evers' family: father, John; mother, Jequita; wife, Tami; daughters, Stephanie and Jennifer; son, Rob; and cousin, Michael Pane.

Chief Justice Charles T. Wells, Florida Supreme Court, administered the Oath of Office prescribed by the Constitution.

The Speaker welcomed the new Member of the Florida House of Representatives and recognized him for brief remarks.

I am respectfully submitting for consideration the proposed procedure for committee and floor action on the appropriations and implementing bills to be considered during the Special Session to begin on October 22, 2001.

Upon convening of the Session the Fiscal Responsibility Council will notice the proposed council bills to be considered at its meeting on Tuesday, October 23, 2001. The proposed council bills will be available to the members and the public at that time. All amendments must be filed no later than 5:00 p.m. on Monday, October 22, 2001.

Amendments will be filed with the Fiscal Responsibility Council, Room 221, The Capitol. Member requests for staff to draft amendments shall be deemed as timely filed if received before the relevant deadline.

Pursuant to House Rule 12.5, amendments to the appropriations bills must be balanced with increases offset by equivalent or greater decreases within the jurisdiction of the same appropriations committee. Requests to draft amendments must include the item to be funded and the item from which funding is to be reduced.

Amendment deadlines apply to all members, including members of all Appropriations Committees and the Fiscal Responsibility Council.

The Fiscal Responsibility Council will meet at the noticed time on the morning of Tuesday, October 23, 2001, and will consider all timely filed amendments. Pursuant to House Rule 6.5, after consideration and amendment of all PCB's, the Council will combine the bills into a single Council appropriations bill and Council implementing bill.

The Fiscal Responsibility Council will publish the General Appropriations Bill and related implementing bills, as amended, as early as possible on Wednesday, October 24, 2001.

All floor amendments to be considered on second reading of the bill must be filed no later than 5:00 p.m. on Wednesday, October 24, 2001. The bills will be read a second and third time on the floor on Thursday, October 25, 2001.

Floor amendments will be filed with the Fiscal Responsibility Council, Room 221, The Capitol. Member requests for staff to draft amendments shall be deemed as timely filed if received before the relevant deadline.

Pursuant to House Rule 12.5, amendments to the appropriations bills must be balanced with increases offset by equivalent or greater decreases. Floor amendments moving spending authority between sections of the bill require a 2/3 vote. Requests to draft amendments must include the item to be funded and the item from which funding is to be reduced.

Amendments will only be accepted from House Members, their legislative assistants, and staff of the Majority and Democratic Offices on behalf of the Member.

This paragraph is repealed July 1, 2003.
