A LETTER FROM...

Representative Gottlieb

Dear Constituents,

I hope this letter finds you well during this unprecedented time. Throughout the COVID-19 pandemic, our communities have shown great resolve and compassion as we all try to navigate these new circumstances. Myself and my staff have been happy to assist wherever we can and working to help connect citizens with assistance. As the legislative session came to a close and bills reached the Governor's desk, several of the bills and appropriations projects I sponsored were signed and approved.





This session, HB 103 was signed by the Governor. The bill provides that a subpoena served on an out-of-state corporation (OOSC) is proper when it is served under the following conditions:

- On a registered agent in this state;
- As authorized by the state where process is to be served; or
- At a location routinely used to accept service, if the corporation is doing business in Florida through the internet.

If a Florida business or OOSC fails to comply with the orders of the subpoena, under the provisions of this bill, an applicant who sought a subpoena can petition in court for compliance through indirect criminal contempt or a daily fine, which ranges between \$100-\$1,000 for up to 60 days. This bill helps remedy issues with compliance and enforcement of subpoenas, which will help aid in the prevention of destruction of evidence and increase compliance with subpoenas that are issued under strict timelines. By helping expedite the actions of the subpoena, this bill allows law enforcement officers and investigators to seek justice and fight cyber crime.

Also this session, we worked hard to pass a landmark bill, HB 23, named “Alyssa’s Law” after Alyssa Alhadeff who lost her life during the fatal shooting at Marjory Stoneman Douglas High School on February 14th, 2017. This bill, co-sponsored by myself and Rep. Daley (D – Coral Springs), requires public and charter schools to install panic alarms in classrooms for use under specialized circumstances. These panic alarms, referred to as “Alyssa’s Alert,” will link to local law enforcement for real-time coordination between multiple first responders. This enhanced emergency system will reduce response times by law enforcement, fire departments, and emergency medical services to save our children’s lives.



I’m very proud to have sponsored this bill for Lori and Ilan Alhadeff. Their tragedy has given way to a unique way of providing security to our children and teachers. Our first responders will benefit from this new technology as well. Today, the State of Florida is safer from their efforts and I am proud to help Make Our Schools Safe.

In addition to the impactful bills we passed, we also were able to secure appropriations for a variety of projects in our communities. They include, JAFCO Children’s Abilities Center, ARC Broward Skills Training for Adults with Disabilities, and RESTORE Ex Offender Reentry. With this funding, these organizations can continue to provide valuable resources and programming for the members of our community. Unfortunately not all of our requests were approved and received funding. However, I look forward to working towards generating these necessary dollars for our community during our 2021 session.
