





TO WHOM IT MAY CONCERN: Notice is hereby given of intent to apply to the 2020 Florida Legislature, in the 2020 regular or any special or extended sessions, for passage of an act relating to Wakulla County, having the effect of creating the Wakulla County Airport Authority (Authority) and providing: the boundaries of the Authority; the Authority's purpose and special district classification; membership of the Authority governing board; powers of the Authority and limitations on same; and an effective date.

A public meeting is being held on Monday, November 18, 2109, from 3:00 p.m. to 4:30 pm in the Wakulla County Commission Chambers, 29 Arran Road, Crawfordville, FL for a public discussion on the proposed Authority legislation.
