The funding will be used for the FAMU-FSU College of Engineering to undertake planning and design for Building C and to complete repairs/remodel in Buildings A & B. On September 15, 2017 an Educational Plant Survey was conducted by the Board of Governors survey team. The survey used current enrollment numbers (as opposed to projections 5 years out) and recommended construction of 104,000 NASF in order to provide needed educational space.
