The City of Springfield's drinking water distribution piping infrastructure has exceeded its service life and now has severe tuberculation (development of small mounds of corrosion in pipes) and a high non-revenue water loss. Tuberculation is detrimental to the City's pipes. The current condition of portions of the City's infrastructure is directly affecting operational and maintenance costs of the system as well as system operations. It is vital that the problems in the system be fixed.
