A new acoustic shell was installed at the Mahaffey Theater during Summer 2017. Now with the new acoustic shell in place, orchestra risers are recommended to improve hearing conditions for both musicians and patrons, and to improve the viewing of the orchestra by patrons seated within the orchestra level seats. The new storage facility will serve as storage for the risers when they are not in use, as well as provide vital storage space to the Mahaffey Theater.
