This project will increase flow and pressure in the water system, provide fire protection for residents along US 331 and surrounding areas from Sparkleberry Lane to the Post Office. Looping of the system allows the system to maintain continuous positive pressures throughout the area and thereby prevents the entry of contaminants into the water system, reduces the depletion of disinfectant residuals and decreases the formation of disinfection by-products, as well as promotes water conservation.
