

SECOND RENEWAL AGREEMENT FOR STATE LOBBYING SERVICES

This Agreement (the "Second Renewal Agreement") is entered into this 1 day of November, 2019, between the City of Miramar, Florida (hereinafter "City") and Ronald L. Book P.A. a Florida Professional Association, with its principal business address located at 18851 N.E. 29th Avenue, Suite 1010, Aventura, FL 33180 (hereinafter "Provider").

RECITALS:

WHEREAS, on November 1, 2016, the City of Miramar executed the agreement for State Lobbying Services with the Provider (the "Original Agreement"); and

WHEREAS, the Original Agreement provided for an initial two (2) year term with the option to renew for three (3) additional one-year terms; and

WHEREAS, the initial term of the original agreement commenced on November 1, 2016 and expired on October 31, 2018; and

WHEREAS, the City exercised the option to renew the original agreement for the first renewal term commencing November 1, 2018 through October 31, 2019; and

WHEREAS, the City wishes to exercise the option to renew the state lobbying services agreement with the Provider for the second one-year renewal term commencing on November 1, 2019 through October 31, 2020; and

WHEREAS, pursuant to City Code, approval of the City Commission was not required for the award of the original agreement and thus is not required for the renewal agreement.

NOW, THEREFORE, the parties, in consideration of the mutual promises and covenants contained in the Original Agreement, the First Renewal Agreement and this Second Renewal Agreement, agree as follows:

1. The foregoing Recitals are true and correct and are incorporated and made a part of this Second Renewal Agreement.
2. The Agreement shall be renewed for the second one-year renewal period commencing on November 1, 2019 through October 31, 2020.
3. All covenants, terms, and conditions contained in the Original Agreement, the First Renewal Agreement and this Second Renewal Agreement, including but not limited to rate and/or amount of compensation, shall remain in full force and effect through the second renewal term.
