

**AGREEMENT FOR RENEWAL OF
INDEPENDENT CONTRACTOR'S AGREEMENT**

THIS AGREEMENT FOR RENEWAL OF INDEPENDENT CONTRACTOR'S AGREEMENT (hereinafter "this Renewal Agreement") is made and entered into effective the 1st day of October, 2019, by and between **OKEECHOBEE COUNTY**, a political subdivision of the State of Florida (hereinafter the "COUNTY") and **CAS GOVERNMENTAL SERVICES, LLC**, a Florida Limited Liability Company (hereinafter "CONTRACTOR").

WITNESSETH

WHEREAS, the COUNTY is a political subdivision of the State of Florida, having a responsibility to provide certain services to benefit the citizens of Okeechobee County; and

WHEREAS, the COUNTY and CONTRACTOR entered into an Independent Contractor's Agreement dated September 13, 2018 (hereinafter the "2018 Agreement"); and

WHEREAS, the CONTRACTOR has provided services under the Agreement, in a manner satisfactory to the COUNTY; and

WHEREAS, the 2018 Agreement provided for a one (1) year Term commencing October 1, 2018, and provided for two (2) additional one (1) year terms, upon written agreement by the parties, and the parties are desirous of extending the 2018 Agreement.

NOW THEREFORE, in consideration of the premises, and in consideration of the mutual conditions, covenants, and obligations hereafter expresses, it is agreed as follows:

1. **Recitals.** The foregoing recitals are true and correct and constitute the material basis for this Renewal Agreement. Said recitals are hereby ratified and made a part of this Renewal Agreement.
2. **Renewal.** The 2018 Agreement is hereby renewed and extended for an additional one (1) year term, through September 30, 2020.
3. All remaining terms, provisions, and conditions, including, but not limited to the terms for payment, of the 2018 Agreement dated September 13, 2018, remain in full force and effect.
